FROM ROUTE 495: Take Exit 23B Route 9 West. Once on Rt. 9 go 1.7 miles to Rt. 30 West (exit on right) in .1 mile turn right onto Rt. 30. Straight on Rt. 30 for 1.5 miles. At second set of lights turn left into Bay State Commons. Follow the access road through the shopping center staying to the left for .4 miles. Keep Boston Sports Club on your right and follow the road behind the building. Turn left onto Brigham St., *a gravel road, follow for .2 miles, turn right into the parking lot and our building will be on your left side. Do not drive past the building. SureFire Dogs entrance is on your left towards the end of the building. Orange door.

From 135 North: Follow 135 north into the Westborough rotary. Take the first right out of the rotary onto Brigham St. Continue on Brigham St for .7 miles. * follow directions above.

From 30 East: Follow 30 east into the Westborough rotary. Take the second right out of the rotary onto Brigham St. Continue on Brigham St for .7 miles. * follow directions above.
